MINUTES

Members present: Chair Arch Gillies, Sandra Oliver, Jay T. Zlotkowski (tardy) , and Craig Olson. Excused Fred Rollins.

Others Present: Janet Anderson- Town Manager and Vern Ziegler - Town Assessor

The meeting was called to order at 6:15 PM, and a quorum was established.

MOTION by C. Olson to approve the minutes of December 18, 2013 as written. S. Oliver seconded the motion and it passed 3-0.

VISITOR'S COMMENTS:

1. <u>Christmas Ice Storm</u>:

A mailer went out with a thank you to some of the individuals who helped during the Christmas ice storm. MOTION by S. Oliver to approve a resolution on behalf of the Town of Islesboro thanking those individuals for their help. C. Olson seconded the motion and it passed 3-0.

2. <u>Steve Miller - Letter dated 12/31/13 regarding emergency preparedness for extreme weather events.</u>

A. Gillies asked Steve Miller to put his thoughts and questions in writing regarding the town's response during the past two extreme weather events as Steve had approached him with concerns. J. Anderson said that a lot goes on behind the scenes that citizens may not be aware of. The BOS would like to find a way to communicate to the general public what does go on behind the scenes. J. Anderson is planning a meeting to discuss how things went during the ice storm, but wants to wait until Fred Rollins, CMP Island Rep, returns. She will bring Steve's concerns to the meeting. She notes that the Fire Department and the EMS currently need more volunteers.

3. Vern Ziegler, Town's Assessor, Full Value Tax Rate Comparison

V. Ziegler discussed how variations in each municipality's ratio of assessed value to market value make it difficult to compare Mil Rates between towns. Two towns with the same tax amount due on a property with a market value of \$100,000 can have very different Mil Rates depending on assessed value. For example, the annual tax on a house valued at \$100,000 in Islesboro is \$800 and the annual tax on a house with same value in Lincolnville is \$1,346.00. The BOS would like Vern to discuss this concept at the Winter Informational Meeting, but he will be out of town. The handout with these findings will, however, be made available at the meeting.
