Article 1. To elect a moderator to preside at said meeting. TOM TUTOR ELECTED MODERATOR – 2 YES 1 SCATTERED
Article 2. WRITTEN BALLOT – DOES NOT PASS – TOTAL VOTES 71: 35 YES 36 NO To see if the Town will vote to authorize a three year Special Deer Hunt to be conducted from November 2, 2015 through January 30, 2016; November 7, 2016 through January 31, 2017; and November 6, 2017 through January 31, 2018 (<i>i.e.</i> , with some overlap with the Expanded Archery season on Islesboro) on such terms and conditions as recommended to the Board of Selectmen by the Deer Reduction Committee; subject to the approval of the Maine Department of Inland Fisheries & Wildlife; and subject to an annual review by the Board of Selectmen. <i>After a lengthy discussion, with questions and answers between the deer reduction committee and the public a motion was made to move to a vote</i> MOTION WAS MADE AND SECONDED TO HAVE A SHOW OF HANDS FOR A WRITTEN BALLOT – PASSED

Article 3. WRITTEN BALLOT – PASSED – TOTAL VOTES 72: 45 YES 27 NO

To see if the Town will vote to authorize a three year Special Deer Hunt to be conducted from December 14, 2015 through February 29, 2016; December 12, 2016 through February 28, 2017; and December 11, 2017 through February 28, 2018 (i.e., without any overlap with the Expanded Archery season on Islesboro) on such terms and conditions as recommended to the Board of Selectmen by the Deer Reduction Committee; subject to the approval of the Maine Department of Inland Fisheries & Wildlife; and subject to an annual review by the Board of Selectmen.

The Selectmen give notice that the Registrar of Voters will be at the G.H. Kinnicutt Center on Thursday, June 11, 2015 from 5:30pm to 6:00pm for the purpose of accepting registrations and correcting the voting list. A person who is not registered to vote may not vote in any election.
