Islesboro Municipal Broadband Network (IMBN) - Select Board Update 4/6/16

Goals

- o 100% residential and business properties connected at 1-gigabit at one low price for all
 - 775 known residential and business properties at this time
- o Internet speed and capability at least as good as nearby mainland now and for generations
 - 1-gigabit is 300 times faster than DSL Internet currently available on the island.
 - Can stream multiple TV signals and replace satellite TV
 - Wi-Fi, wired Ethernet and optional unlimited phone service
- Supported by on-island techs plus 24x7 phone support
 - Fiber repairs, installations and service restorations

Principles

- o Town owns the system & contracts with GWI to operate, monitor, manage, support, repair
- o Must be good deal for subscribers and manageable for taxpayers
- o Designed to be robust for island environment, last several generations and be upgradable as time and technology change.
 - o 1-gigabit is on par with larger US metro areas. The IMBN fiber backbone could deliver much faster speeds/capacities in future with new electronics
- o · Construction to start ASAP after positive vote and bond funds available to pay bills.
- o Straightforward financial & operational processes so that town can manage it as a department much like the Health Center.
- High momentum preparing for a Town Meeting vote on June 18th
 - o May 16th package and presentation ready for Select Board Meeting May 18th
 - Construction Scenario, Schedule, Costs
 - Bond Measure details
 - Subscriber Deal Schedule of Fees, Support, etc.
 - Operating Business Plan revenue, expenses. How it operates, who fixes it, etc.
 - Who Does What? Responsibility Matrix of all the stakeholders.
 - Town Budget implications for construction & partial year operation in 2017 as well as estimates for the operational years beginning in 2018
 - Warrant article(s) draft
 - o May 26th Town Public Info Meeting
 - Prepare Voters to make an informed decision
 - Detailed IMBN presentation with questions and answers
 - Written Package a la the May 16th Select Board package available to all
 - Becoming an IMBN Subscriber pamphlet
 - o May 26th thru June 17th –info meetings, public sessions at CC, 1x1 meetings as requested.
- Finalizing the Bond Measure Status
 - o Primary Construction Bids
 - o Town opened bids from 5 companies. Bidders could bid on 1, 2 or 3 of the scopes. These scopes and their relative cost are:
 - Scope A Outside fiber backbone cabling, Central Office building \$\$\$\$\$
 - Scope B Install and configure electronics inside Central Office \$
 - Scope C –Installation service at 775 premises (one per property) \$\$
 - Signup process Contract adjustable for the number actually installed.

- Owners may *opt out* of construction time installation but deciding later will incur an install fee, as it will be more expensive to do later.
- Notified Waveguide, the Scope A and C low bidder, and will soon begin value engineering (looking for savings) and drafting a contract (with schedule) that could be signed after a positive vote. In addition to being the low-bidder, Waveguide is very experienced building similar systems, has good references and several suggestions for value engineering.
- Working to clarify Scope B bids (may need to rebid in a quick turnaround process)
- Other Construction Bond Items
 - OPM Bid The Owner's Project Manager bids open in 2 weeks. OPM is Town's day-to-day construction project manager and in-house expert on the construction contracts, who does what, and the schedule. Reports to Town Manager. A highly specific, trained person/company. OPM will start ASAP after positive vote and depart just after our acceptance testing is done and subscribers are lit up.
 - Pole Make Ready We have CMP & Fairpoint estimates re roughly 1800 utility poles. Estimates are high but we can't value engineer these until after vote when we can pay a deposit.
 - Draft contracts with CMP (undersea cable fiber lease) and Maine Fiber Company (*Three Ring Binder* fibers on mainland).
 - Tilson final design drawings work order, if needed
 - GWI Construction Phase Oversight work order testing and acceptance
 - Construction Contingency Fund
 - Initial Inventory of spare parts, used bucket truck with tools
 - Initial Capital Reserve for storm restorations, out of warranty electronics replacement, etc.
- Operating Business Plan
 - o Drafted Terms and Conditions with GWI awaiting contract draft and estimated operating costs
 - o Drafted Subscriber deal, fees schedule, policies and procedures
 - o Pro forma Financial Model Revenues and Expenses to inform fee schedule decisions
 - o Operational Overview for Town Manager with Responsibilities Matrix
 - o Becoming an IMBN Subscriber pamphlet
 - What do you get and why is it a benefit?
 - Preparing your property for installation
 - Subscriber Agreement
- Other Status Items
 - o Sally Daggett, the town attorney, is fully involved in all aspects of the legal work
 - o Baller and Herbst, Washington DC attorneys & experts in FCC and Federal rules consulted
 - We asked for and received help from Corning and Cienna vendors with ties to Islesboro.
 - We continue to pursue any and all potential grants, etc. to offset the cost to construct or help people with subscription cost.
