MINUTES

Chair Harmen called the meeting to order at 6:15 PM and a quorum was established.

MOTION BY K. Schwarzenbach to approve the minutes of June 2, 2014 as written. G. Rivera seconded the motion and it passed 4-0.

OLD BUSINESS

Jonathan Cohen, Map 21, Lots 2F & 2G, Application #11-14

This application for the installation of a 6' x 66' wooden pile supported dock with seasonal ramp and float, and the installation of a 5' wide stone dust path from the boathouse to the proposed dock was tabled for a site review and for receipt of the permit from the Army Corps.

Site Review: Gil Rivera submitted the Site Review Report, and verbally reported that

everything was found to be in order with all setbacks well marked. MOTION by P. Coombs to accept the Site Review Report for Jonathan Cohen, Map 21,

Lots 2F & 2 G. G. Rivera seconded the motion and it passed 4-0.

Army Corps Permit: The copy of the Army Corp Permit was received and filed with the

application.

Harbor Committee Report: P. Pike and B. Boardman both received a verbal report from

Robert Achorn, Assistant Harbor Master, who performed a site review on this project. Mr. Achorn said that this dock would not create any navigational problems and he sees no problems

with the application.

The Planning Board found the application to be complete and the following motion was made: MOTION by K. Schwarzenbach to approve Application #11-14 for Jonathan Cohen, Map 21, Lots 2F & 2 G for the construction and installation of a 6' x 66' wooden pile supported dock with seasonal ramp and float, and the installation of a 5' wide stone dust path from the boathouse to the proposed dock. P. Coombs seconded the motion and it passed 4-0.

NEW BUSINESS

J. Harmen reported that she is going to begin looking at the Land Use Ordinance, with the help of Marc Schnur, with an eye toward creating language that would require a Findings of Fact for a Land Use Application whether approved or denied, thus creating a clear and definitive record for the file in case of any potential litigation. She feels that the Land Use Ordinance should include criteria for approval for which to use in reviewing an application.
